### Biological Safety

Facilitate compliance with regulations and NIH guidelines for research involving bio-hazardous materials. Review protocols to ensure the safety of people and the environment.



### Chemical Safety

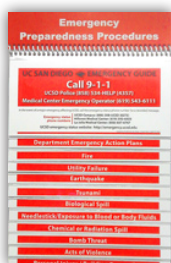
Implement the campus Chemical Hygiene Program through information, training, and standard operating procedures and requirements for the safe handling of chemicals.



### Controlled Substances

Facilitate secure acquisition, use, and disposal of Controlled Substances, List I Chemicals, and California Precursors for research, teaching, and veterinary activities.



### Emergency Response

Distribute the UCSD Emergency Guide for UCSD employees, students, and visitors. Activate after hours emergency response teams to evaluate and handle hazardous material emergencies on UCSD property.



### Environmental Protection

Prevent release of hazardous materials to the air, soil, or water by implementing best practices, training, and monitoring programs. Manage environmental permitting and reporting requirements.

Redesign user interaction with equipment, workplaces, and tasks to reduce musculoskeletal injuries. Assist employees with training, Ergonomics Resource Fund, Shoes for Crews, Pain Relief, and Pain Away Programs.



### Event Safety Review

Review special event plans to help event sponsors identify and resolve potential safety and liability issues to create the best possible conditions for safe, successful events.



### Fire & Life Safety

Ensure campus fire protection systems are inspected, tested, and maintained. Perform Fire & Life Safety plan and construction review of new buildings and renovations. Identify and eliminate workplace fire hazards.



### Food Safety

Protect the public from food borne illness by implementing sanitation requirements for sale or distribution of food to the public by restaurants, cafeterias, mobile food facilities, catering services, and special events temporary food vendors.



### General Safety

Manage accident investigation and injury prevention programs and regulatory compliance for non-research workplaces, including offices, shops, studios, housing, and dining.

### Hazardous Materials

(858) 534-9745

Clean up hazardous material spills that are too large or too dangerous for workers to handle. Manage permitting of hazardous materials activities and contingency plans in compliance with regulatory requirements.



### Radiation Safety

(858) 822-2494

Facilitate regulatory compliance of research and clinical activities involving radioactive materials, radiation-producing machines, and research lasers. Administer the dosimetry program to detect employee exposures.



### Hazardous Waste Disposal

Collect, transport, process, store, and dispose of hazardous waste in accordance with local, state, and federal regulations.



### Research Safety

(858) 534-5366

Provide safety services to protect researchers and visitors from hazards within laboratory facilities. Conduct routine audits of research space for regulatory compliance.



### Public Health and Sanitation

Oversee campus health and sanitation programs for water quality, pool sanitation, playgrounds, and food inspections. Issue advisories for moderating spread of infectious illnesses such as seasonal flu.



### Risk Management

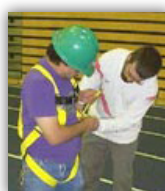
Provide liability, loss control, and legal resources and consultation for managing risk.

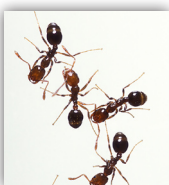
Implement injury and illness prevention programs for respiratory protection, hearing conservation, heat illness and skin cancer prevention, asbestos, lead, exposure assessment, indoor environment quality, and personal protective equipment.



### Safety Training

(858) 822-5974

Provide required and recommended safety training so employees are aware of potential job-related risks and know how to perform their work safely. Manage the campus-wide Department Safety Coordinator program.



### Pest Services

Use an Integrated Pest Management (IPM) approach to determine if a UCSD facility needs treatment. IPM employs physical, mechanical, cultural, biological, and educational methods to limit pest problems.



### Workers' Compensation

Administer UCSD's workers' compensation benefits program for employees who are injured or who develop an illness as a direct result of their employment.
